Ad EU GDPR Article 14 Para. 2

(a) Austrian Airlines AG/Technical Training is liable to store all participants' data for an infinite period as required by EASA Part 147.A.125.

(b) Being subject to EASA regulations Part-147 regulations Austrian Technical Training is liable to obtain and process all participant's data.

(c) You have the right to be informed about the processing of your data (Art 15 GDPR).
You have the right to rectification of your personal data (Art 16 GDPR).

You have the right to demand deletion of your personal data as long as you have not enrolled in one of our classes since on that condition we are obliged to store all participant's data for an infinite period in compliance with EASA Part-147.A.125 (Art 17 GDPR).

You have the right to demand the limitation of the processing (Art. 18 GDPR).

You have the right to portability of your personal data in a computer readable format (Art 20).

You have the right to object to the processing of your personal data (Art. 21 GDPR). However, exercising your right of objection would result in terminating your further participation in the class, as establishing your identity constitutes an essential precondition for your participation.
